AFPD Battalion Chief Justin Yelinek charred the following call volume and distribution for July so far: 15 total calls; 3 vegetation fires, 1 other debris burn, 6 medical aid, 1 gas leak and 3 public assists.

Regarding training nights, he said that he had attended LFPD's Thursday night training and talked with everyone about merging LFPD's training into AFPD's Wednesday night training, which was received positively. The general mood was positive, excepting the burnout felt by the core 3 responders for the district, who were deserving of some recognition and gratitude, and a break, which would be facilitated by having AFPD Volunteer firefighter Nick Darrow staff station 151.

He also shared that he had spoken to AFPD Chief Withrow and Stacy and Charlene in finance, and determined it's possible for them to provide treasurer services for LFPD to help save money wherever possible by not needing to hire another.

It was reported that LFPD Auxiliary Treasurer Terry Bolyard's weedeaters of choice had quoted the cost of completion at \$600 total.
