# AMENDMENT TO THE MASTER JOINT OPERATIONS AGREEMENT BETWEEN THE AMADOR FIRE PROTECTION DISTRICT AND THE LOCKWOOD FIRE PROTECTION DISTRICT

	This Amendme	ent to the Master Joint Operations Agreement between the Amador County
Fire	Protection Distric	t and the Lockwood Fire Protection District ("Amendment") is entered into
this	day of	, 2024, by and between the Amador Fire Protection District
("Al	FPD") and the Loc	kwood Fire Protection District ("Lockwood").

#### **RECITALS**

WHEREAS, on July 19, 2022, AFPD and Lockwood entered into a Master Joint Operations Agreement setting forth the cooperative relationship between the agencies regarding the provision of fire protection and emergency medical services; and

WHEREAS, the parties desire to amend the Master Joint Operations Agreement to provide that the AFPD Fire Chief, or his or her designee, will serve as and perform the duties of Fire Chief for Lockwood as provided below.

NOW, THEREFORE, AFPD and Lockwood, for and in consideration of the mutual promises and agreements herein contained, do agree as follows:

- 1. As set forth in more thoroughly in Attachment A to this Amendment, the AFPD Fire Chief shall serve as and perform the duties of Fire Chief for the Lockwood Fire Protection District.
- 2. This Amendment shall terminate automatically upon Lockwood's dissolution and annexation with AFPD. This Amendment may also be terminated earlier by either party upon 60-days written notice to the other party. In the event of a termination of this Amendment, not involving a merger of the two agencies, all equipment, records, or other property shall be returned to the original owner within 60-days of the effective date.
- 3. For the services provided pursuant to this Amendment, Lockwood shall make a monthly payment to AFPD of \$3,000. The payment for any partial month shall be prorated.
- 4. Except as set forth in this Amendment, the Agreement shall remain unmodified and in full force and effect.

This appendix does not in any way change the current Joint Operations Agreement or preclude the Lockwood Fire Protection District from remaining an independent special district, with its own duly elected Board of Directors.
The AFPD Fire Chief, or his or her designee, shall serve as and perform the duties of Fire Chief for the Lockwood Fire Protection District. Those duties shall include, but not be limited to the following:
• Respond to emergency and non-emergency calls, deploying fire apparatus and fire personnel in the most advantageous manner for the control and extinguishment of fire.
Demonstrate leadership and effective supervision under unusually stressful conditions in both emergency and non-emergency situations.
<ul> <li>Provide administrative oversight and participate in the development of policies and procedures supporting overall fire district administration and operations.</li> </ul>
• Working with the Treasurer and the Board of Directors to submit requests for new acquisitions and work within the established fire district budget, including the procurement of equipment and supplies. Follow District procedures for documenting expenditures, as outlined in the Operation and Procedure Manual (paragraph 3040.4). Assist the Board and Treasurer with

• Ensure an adequate number of trained and equipped volunteer firefighters are

annual budgeting of District operational and personnel expenses.

available for emergency response.

• Ensure all LFPD apparatus and facilities are well maintained, response ready, and presentable for the public.
• Effectively promote and enforce a work environment that is free of discrimination or harassment of any kind, with zero tolerance for any such behavior or act.
• Identify problems early and taking appropriate action when problems arise, thereby fulfilling supervisory responsibilities as required by law while adhering to LFPD policy and procedures.
• Promote safe work practices and provide a safe work environment for all volunteers and the public.
• Plan, organize, direct, control and evaluate all Fire District operations for fire suppression, training, communications, prevention, fire investigation and emergency medical response.
• Work cooperatively with allied agencies and neighboring jurisdictions for the benefit of LFPD in providing effective and efficient emergency responses.
• Remain current in modern fire protection organization standards and management practices used to deliver structural fire protection and other emergency services.
• Provide supervision and oversight of the care, maintenance, application and replacement of personal protective equipment, mobile equipment, facilities, infrastructure and other equipment, to include an accurate inventory of equipment as appropriate.
• Remain current and well versed in various state, local, and federal laws, codes and ordinances relating to life hazard, fire hazard and risk reduction policies.
• Respond promptly to complaints or concerns from citizens, with the goal of determining reasonable solutions for all parties, including the district.

•	Represent	LFPD's in	iterests in	various	County	organızat	ions as a	appropri	iate.

- The JOA including this addendum shall be revisited upon any personnel changes regarding the Fire Chief position for AFPD.
- If the LFPD Board finds by a majority vote that the AFPD assigned acting Fire Chief is not fulfilling the requirements of this agreement and/or not acting in the best interests of LFPD, the LFPD board will send a resolution stating such to the AFPD Fire Chief, who will then assign an alternative Chief to serve at LFPD.

WHEREAS, on July 8, 2024, the Fire District adopted Resolution 2024-1, entitled "A RESOLUTION

WHEREAS, a Notice of Election must be filed with the Amador County Registrar of Voters specifying

which offices are to be filled at this election; and

WHEREAS the Fire District boundary map has not changed since the last election held in 2022; and

WHEREAS Amador County intends to conduct a consolidated election on November 5, 2024; and

WHEREAS, the consolidation of elections may serve to reduce election expenses to taxpayers and

may increase voter turnout; and

WHEREAS, a Candidate's statement, if desired, is to be paid by the Candidate; and

WHEREAS, the Amador County Elections Department must be Authorized to conduct the election and

to canvass all returns; and

WHEREAS, Amador County should be reimbursed for the actual costs of the election; and

WHEREAS, a pre-determined tie-breaking method should now be designated to prevent any possible

dispute as to the final outcome of the election; NOW,

THEREFORE, BE IT RESOLVED, that the Fire District does hereby 1.) Call for an Election to be held

to elect Four seats. 2.) Request that its General Election to elect Four seats be Consolidated with the General

Election scheduled for November 5, 2024; (3.) File it is Notice of Election with the Registrar of Voters specifying

the elective offices to be filled; (4.) Submit a list of incumbents and terms of offices; (5.) Require that a

Candidate's Statement, if desired, is to be paid by the Candidate; (6.) Certify the current boundary map is
